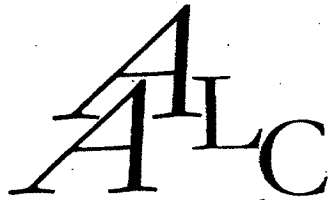


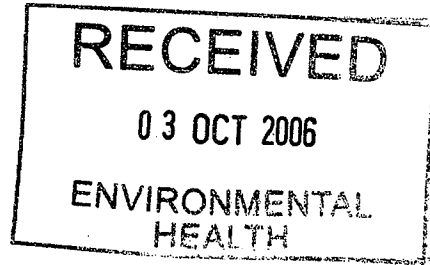

Dear Mr. Inkpen,

Re: The Rose and Crown, Market Place, Chippenham, Wilts.

I am now in receipt of the correspondence between Jacqui Gallimore and Mr. Jeffrey Olsen dated 12th September 2006.

I have spoken to Mr. Jeffrey Olsen (senior), and he agrees the following:-

1. That there shall be no sale of alcohol from the beer garden at the front of the premises. This does not prevent a temporary event notice being served for the sale of alcohol from this area.
2. That regulated entertainment shall not be permitted in the beer garden at the front of the premises. This does not prevent a temporary event notice being served for regulated entertainment to take place in this area.
3. A minimum of three door supervisors will be employed on a Thursday and Friday night from 2100 until the last customer has left the premises.
4. Four door supervisors will be employed on a Saturday night from 2100 until the last customer has left the premises.
5. Door supervisors will be employed on other occasions at the discretion of the Designated Premises Supervisor if deemed appropriate following a risk assessment.

6. The terminal hour for the sale of alcohol on Thursday to Saturday, 17th December to 30th December and 2nd January to 7th January and Bank Holiday weekends (Sunday to Monday) shall be 1000 – 0230 (regulated entertainment between 1000 – 0215)
7. The hours open to the public Thursday to Saturday, 17th December to 30th December and 2nd January to 7th January and Bank Holiday weekends (Sunday to Monday) shall be 0900 – 0300
8. The request to extend opening hours and extend the sale of alcohol for international and national sporting events shall be removed.

I hope that this now addresses all of the issues raised by the police, and that the application can now proceed to it's conclusion.

RE: THE BLACK HORSE, CHIPPENHAM

I understand that the police have no objections to this application. Could you please indicate to me as soon as possible whether the new licensing hours can now be adopted?
