After the age of 45 you will need a medical every 5 years and after the age of 65 a medical every year (please note that after the age of 70 the examination will be undertaken by the Council's Medical Advisor). If you have sent us a medical in the last 12 months, do not send one now.

Drivers who hold a current HGV or PSV Licence will not require a medical examination, but will be required to produce the relevant Licence for inspection.

Driver's completed application forms must be returned to the address below, accompanied by:-

- a). Required Fee. Cash or cheques made payable to North Wiltshire District Council. If the application is an initial application the fee is **£131.00**. If the application is a renewal application the fee is **£78.00**.
- b). The latest issue by the DVLA of your full Driver's Licence must be produced for inspection before a Hackney Carriage/Private Hire Driver's Licence is issued.
- c). At least two colour passport type photographs. (It is advised that such photographs are obtained by means of a photographic booth).
- d). Completed CRB Disclosure Application Form – required on initial application and then every 3 years. If this is a renewal licence, a form will have been provided with your renewal letter. Fee for this is **£33.00**.
- e). Completed Medical Form (**if necessary**) unless submitted separately by the General Practitioner. Please note the Medical Form can be submitted at a later date, however no decision can be made as to whether or not a licence can be granted without the application being completed in full, which includes the medical report form.

GUIDANCE NOTES FOR MAKING APPLICATION

1. All Licences expire one year from the date of issue, in each year, or at such other times as the District Council shall decide.
2. The Driver's Licence is personal to the driver, but should be held by the proprietor/operator during the course of employment.
3. The applicant will be issued a Driver's Licence subject to:
 - (a) satisfactory completion of the application form, and the requirements set out in Paragraph 4(d) of the application form
 - (b) the Council being satisfied that the applicant is a fit and proper person to hold a Driver's Licence.
4. A driver's badge, bearing his name, licence number, expiry date and photograph of the holder, will be issued and must be worn at all times whilst driving on Hackney Carriage or Private Hire business.
5. Applicants must not drive a hackney carriage or private hire vehicle until issued with a badge and a Licence. Applicants will appreciate that it may take 4 weeks to process the application. It may be necessary to refer applications to the Council's Licensing Committee for determination which will increase this period.
7. ONLY a Licensed Driver may drive a Hackney Carriage or a Private Hire Vehicle.
8. The Council shall not grant a Licence to any person who has not for at least 12 months been, and is not at the date of the application for a Driver's Licence, the holder of Licence granted under Part III of the Road Traffic Act 1972 (Not being a provisional) authorising him to drive a motor car. That is you must have held a full Licence for one year.
9. You are required to disclose on the application for all previous convictions except spent convictions as laid down by the Rehabilitation of Offenders Act 1974 as outlined below. If you are unclear on how this may affect you, please do not hesitate to contact **Jo Tarry on 01249 706438**.

Imprisonment of between 6 months and 2 years	10 years
Imprisonment of up to 6 months	7 years
Borstal Training	7 years
A fine or other sentence not otherwise covered in this table	5 years
Absolute discharge	6 months
Probation Order, conditional discharge or bind over.	1 year (or until order expires whichever is longer)
Detention Centre Order	3 years
Remand home, attendance centre or approved school order	The period of the order and a further 2 years after it expires
