COUNCIL TAX
APPLICATION FOR DISCOUNT
MEMBER OF A VISITING FORCE

A discount from the Council Tax is given where there are fewer than 2 adults normally resident in a dwelling.

A person who has a relevant association with a visiting force will not be taken into account when assessing the number of adults resident.

A "visiting force" is any body, contingent or detachment of the forces of a country to which the Visiting Forces Act 1952 applies. The countries are listed overleaf.

A "relevant association" is:

- (i) being a member of that visiting force or a member of a civilian component of that force, or
(ii) being a person, not a citizen of the United Kingdom or ordinarily resident in the United Kingdom, but being a dependant of a member of that visiting force or of a civilian component of that force.
